### 104/13NPSG Welcome & Apologies

NLB welcomed everyone to the meeting. There were apologies for absence from Peter Ambrose, John Knight, Neil Rusbridger, Cllr Kevin Andreoli and Cllr Glenn Crooks.

#### 105/13NPSG Notes of the last meeting of the Steering Group

The notes for the meetings held on 19 May were received and accepted as an accurate record of the meeting.

#### 106/13NPSG Amendments to the Plan

- i) Amendments to the Plan had been circulated to all members by PA. These were agreed and TD would send off to Neil Homer to incorporate into the Plan
- ii) Policy 8 Travellers Accommodation amendments to this Policy were suggested and these amendments would be sent to NH for comment. TD would also contact Neil March at WCC to determine the legal status of other sites within Denmead. Where there were temporary/unauthorised but existing sites, these could be regulated in the interests of maintaining the current provision. With the suggested amendments, Policy 8 would now read:

The Neighbourhood Plan will support proposals for the development of new sites for settled travellers accommodation, provided they:

I. comprise a self-contained site of no more than two pitches per site;

II. are in close proximity to the settled traveller community in (site to be confirmed) and adjacent to the existing site at (site to be confirmed); and

III. accord with all the relevant policies of the Neighbourhood Plan and the Winchester development plan.

- iii) The boundary of the Primary Shopping Area (PSA) would be amended to incorporate the Lucky Star and Hairdressers and the boundary of the Village Centre would be amended to include the Village Green.
- iv) The boundary at Parklands would continue to run across the rear gardens of the bungalows along Forest Road as it did now. Within the boundary, the two areas of green space would be identified and two lorry parking spaces would also be included. The footpath that runs through the area would also be shown.

#### 106/13NPSG Further Work

- i. The meeting with the proposed developer of Carpenters Field was confirmed. A confirmation of a meeting date was awaited from Southern Water Authority and the Environment Agency. Without such a meeting, a statement would be included into the Plan which they would be asked to accept.
- ii. The Clerk would look to arrange an opportunity for members of the Steering Group to make a short presentation on the Plan to local organisations at their July meetings.
- iii. Statement of Consultation the Clerk had prepared a first draft and sent this out for comment. The draft document was reviewed page by page and amendments and additions identified. A Preface would be included which referred back to previous work undertaken at the time of 'Blueprint'.

iv. The Clerk made members aware of a call from WYG regarding the site to the South of Maple Drive and the planning gain which might be expected if carpenters Field is developed was considered.
